1.0 SCOPE OF THE PERMIT (Refer Clause 2.1 of the General Permit Conditions)

1.1 This Permit is issued to following grades and nominal diameters of "Captain" brand Ribbed Steel bars for reinforcement of concrete(hereinafter referred to as " Ribbed Steel bars"), manufactured by M/S Captain Steel (Pvt)Ltd.(hereinafter referred to as the "Permit Holder") conforming to the requirements specified in the Sri Lanka Standard Specification for Ribbed Steel bars for reinforcement of Concrete; SLS 375:2009, at the factory located at 249/3, Waikkiyawatta Road, Pahala Bomiriya, Kaduwela.

Grades and nominal diameters covered under the Permit:

i) Grade RB 500 Thermo Mechanically Treated Bars(TMT) with Non-Twisted Crescents shape of nominal diameters of 8 mm, 10 mm, 12 mm, 16 mm, 20 mm, 25 mm, 32mm and 40 mm.

1.2 Under the following conditions , the Sri Lanka Standard Institution(hereinafter referred as "SLSI") shall be informed and written prior to manufacture and approval shall be obtain from SLSI before selling the product, if the Permit Holder intends to manufacture;

- Any other size not mentioned above manufactured using the same process
- Ribbed steel bars manufactured using a different process

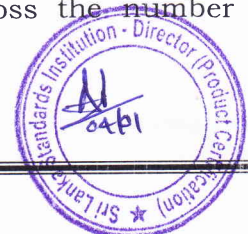
1.3 Product covered under the scope of SLS 375:2009 shall not be manufactured at a location different to that is given under 1.1 above, by the Permit Holder, without holding a valid Permit issued under the Product Certification Scheme of SLSI , for the particular manufacturing location.

2.0 IMPORTED PRODUCTS (Refer Clause 2.5 of the General; Permit Condition)

If the same product bearing the same distinctive brand name is to be imported, written approval shall be obtained from SLSI prior to import the product.

3.0 CERTIFICATION MARK (Refer Clause 3.1 of the General Permit Conditions)

Ribbed Steel bars manufactured in compliance with SLS 375:2009, shall be marked legibly and indelibly with the certification mark(the SLS) of SLSI as given in Column 1 of the schedule of the permit shall be embossed on each and every bar and its). However, if it is practically difficult to emboss the number appearing underneath(i.e. dimensions shall comply with the diagram attached herewith (Refer GL-CP-, if it is practically difficult to emboss the number appearing underneath (i.e. 375), it may be avoided.

5.0 QUALITY ASSURANCE SYSTEM (Refer Clause 4.1 General Permit Conditions)

5.1. The Quality Assurance System of the Permit holder shall comply with the Quality

System Requirements specified SLS mark Scheme(refer GL-CP-01 of SLSI).

5.2. The product shall conform to all requirements specified in SLS 375:2009

6.0 LEGAL REQUIREMENTS

The Permit Holder shall abide by all the legal requirements imposed in the country, relevant to the product.

7.0 VALIDITY OF THE PERMIT AND RENEWAL OF THE PERMIT (Refer Clause 8 of General Permit Conditions)

The Permit is valid for the period indicated in the Permit unless otherwise cancelled by the SLSI due to non compliance by the Permit Holder with any of the conditions under which the Permit has been issued. If the Permit Holder wishes to get the Permit renewed, he/she shall make a request to the SLSI to that effect three months prior to the date of expiry of the Permit.

8.0 PUBLICITY

The Permit Holder is free to publish for the duration of the validity of the Permit that it is an SLS certified product. The publicity shall be provided only for the products categories specified in the scope of the Permit (Clause 1.0 of Specific Permit Conditions).
